

Community Investment Program Guidelines



1. Requests received late will not be considered. No exceptions.
2. Requests indicated as "Sponsorship" opportunities must demonstrate how Fibre Federal Credit Union/ TLC, A Division of Fibre Federal Credit Union, will be recognized. Sponsorship requests must be tied to a specific event, campaign, or activity.
 - a. If you are requesting a "sponsorship" and have a sponsorship deadline sooner than our notification date, please indicate that on your application
 - b. For events or activities taking place at multiple times, please make your request before the first occurrence.
3. Requests indicated as "Donation" requests must demonstrate what the donation will support, specifically, within the organization. Donation requests must not be tied to a specific event.
4. Requests can be made for money, services, or items such as gift baskets or giveaways.
5. Organization, project or event must provide a significant benefit to Fibre Federal's membership and/or the communities we serve, including Cowlitz, Wahkiakum and Pacific counties in Washington, and Columbia, Clatsop, Tillamook and Lincoln counties in Oregon.
6. Priority will be given to complete applications for organizations that are a 501-c(3) or other IRS recognized nonprofit, and demonstrate a significant benefit for the communities we serve.
7. These requests will NOT be considered:
 - a. Religious or church organizations, with possible exceptions for specific humanitarian missions
 - b. Political/ partisan endorsements or affiliations
 - c. For-profit organizations
 - d. Donations for individuals or small groups of individuals, except in rare instances such as personal or family disaster
 - e. Organizations that discriminate against any race, religion, gender, age, creed, sexual orientation, or national origin
 - f. No organizations will be permitted to solicit contributions on Fibre Federal property
8. Due to the number of requests we receive each year, we will not be able to fulfill each request. Our decisions are final.
9. If your request does meet all of our guidelines but does not receive funding, you may submit another request at a later date.
10. If your organization receives funding during one year, you are able to submit a request the following year.
11. We can only make one contribution per calendar year to an organization. Your organization will be ineligible for an additional contribution until the next calendar year.
12. Requests will be reviewed on a monthly basis, on or near the first of each month. Requests received during a particular month will be reviewed in the following month. You are welcome to submit your donation or sponsorship request at any time, however:

- Requests submitted without adequate response time prior to event or sponsorship deadlines will not be considered.
- All requests should be submitted using our online fill-able form, available on our website.
- Requests will be fulfilled throughout the year as funds are available. Thus, requests received earlier in the year may be more likely to be fulfilled.
- Organizations whose requests are denied are welcome to resubmit for a different event or opportunity at any time.
- Organizations will only receive one donation or sponsorship per calendar year, with very limited exceptions.
